Esperamos que usted y sus niños se diviertan usando este calendario como fue crearlo.

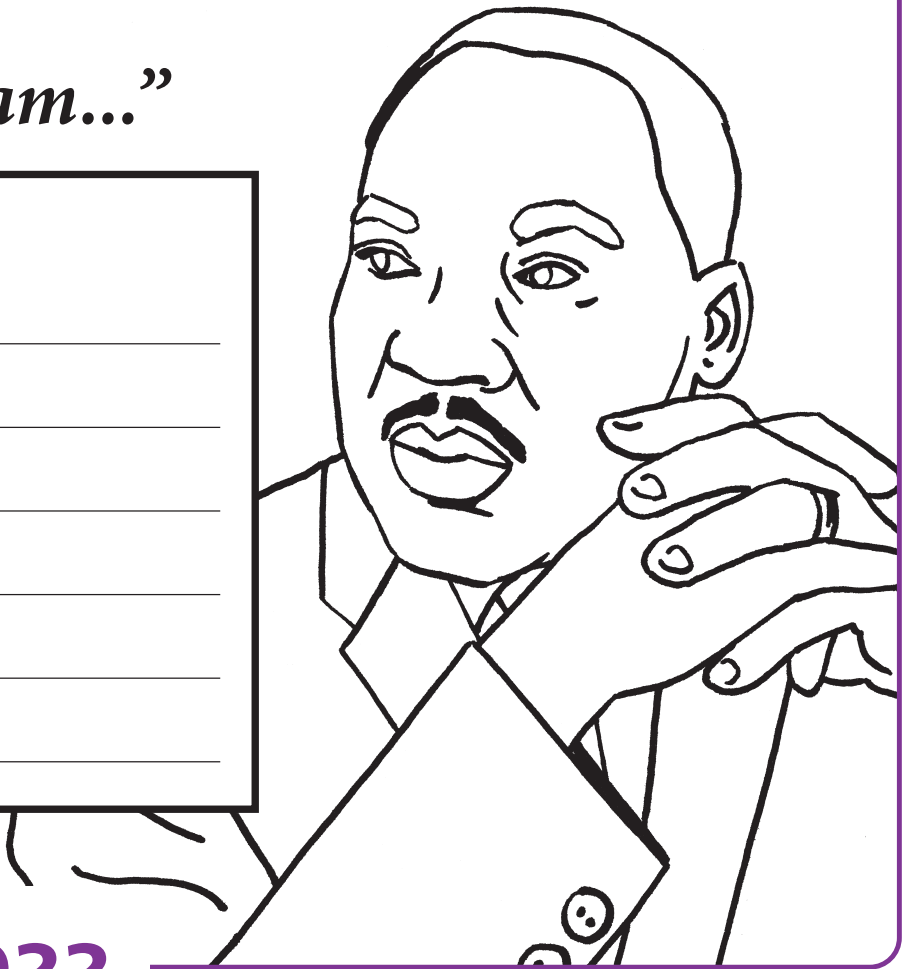

Understanding Indiana's Parenting Time Guidelines

Indiana's Parenting Time Guidelines, issued by the Indiana Supreme Court, help parents who live apart determine how to share time with their children. The Guidelines set out the minimum amount of time that non-custodial parents may spend with their children when the parents are unable to reach an agreement, unless circumstances such as distance or family violence are a factor.

If you have a parenting time order in place, you and your child's other parent should work together, using the Parenting Time Guidelines, to develop a schedule for when your child is to be with each parent. The Parenting Time Guidelines will help you work out a schedule for regular weekday and weekend time, as well as holidays, school breaks, vacations, and special family occasions, all based on your child's age. The Indiana Parenting Time Guidelines can be downloaded from this website:

If you do not have a copy of your parenting time order, you may contact the Clerk's office in the county in which the order was established.

A regular schedule provides children with stability and can help your child look forward to spending time with each of you. The Indiana Parenting Time Guidelines, your court order, and this calendar can help you put together a schedule that everyone understands and can keep track of. You and your child can add your own notes to the calendar to make it truly unique to your family's routines.

The Indiana Parenting Time HelpLine is a free service offered by the Indiana Department of Child Services' Child Support Bureau. The HelpLine is staffed by licensed attorneys who can provide information and education about Indiana's Parenting Time Guidelines and offer referrals for services if needed. (The HelpLine attorneys do not represent callers and cannot provide case-specific legal advice.)

Comprensión de las Directrices de Tiempo Compartido Familiar de Indiana

(Las Directrices de Tiempo Compartido Familiar de Indiana), emitido por la Corte Suprema de Indiana, ayudan a los padres quienes viven separados determinar cómo compartir el tiempo con sus niños. Las directrices establecen la cantidad mínima del tiempo que los padres sin custodia pueden pasar con sus niños cuando los padres no pueden llegar a un acuerdo, a menos que circunstancias tales como la distancia o la violencia familiar son factores.

Si usted tiene una orden de tiempo compartido familiar, los padres del niño deben trabajar juntos, utilizando las Directrices de Tiempo Compartido Familiar, para desarrollar un horario donde su niño pueda estar con cada padre. Las Directrices de Tiempo Compartido Familiar le ayudarán a establecer un calendario para los días de semana y el fin de semana, así como días de fiesta, las vacaciones escolares, las vacaciones y las ocasiones especiales de la familia, todo esto es basado en la edad de su niño. Si usted no tiene una copia de su orden, puede contactar a County Clerk's Office (la Oficina del Secretario del Condado) donde se estableció la orden.

Un horario regular les da a los niños estabilidad y puede ayudar a su niño anhelar pasar tiempo con cada uno de ustedes. Las Directrices de Tiempo Compartido Familiar de Indiana, su orden de la corte, y el calendario pueden ayudarle a establecer un horario cual todos entiendan y sigúan. Usted y su niño pueden agregar sus propias notas en el calendario para hacerla verdaderamente única para las rutinas de su familia.

Indiana Parenting Time HelpLine (la Línea de Ayuda de Tiempo Compartido Familiar de Indiana) es un servicio gratuito ofrecido por Indiana Department of Child Services' (el Departamento de Indiana de Servicios para los Niños) Child Support Bureau. La línea de ayuda está integrado por abogados licenciados que les pueden proporcionar información y educación sobre las Directrices de Tiempo Compartido Familiar de Indiana y ofrecer referencias para servicios específicos para cada caso si es necesario. (Los abogados de la línea de ayuda no representan las personas que llaman y no pueden prestar asesoramiento jurídico en un caso específico.)
