### **Introduction of Members/Housekeeping**

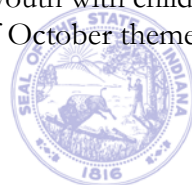
A quorum of members introduced themselves to the gallery. August 19<sup>th</sup> minutes were read and approved. Minutes will be posted to the website.
