Meeting Minutes

Meeting Called to Order at: Regional Service Council meeting was called to order by Mr. Dumas at 5:30 P.M. CST. Joni Tusing gave a Financial Status Report to council members for the month of February, comparing how much has been spent to how much the region was budgeted to spend. Joni reported that region 2 is actually over the budget at this time but is working hard to get back on budget.

b) Community Partners Report:
