 - 1. Budget Report Bob went over expenditures for region. We are at 67% of budget (almost halfway through fiscal year)
 - 2. Probation costs are down approximately 32%

- Currently 18 beds but increasing to 21
- Admittance usually occurs within a week / currently no wait list
- Several DCS referrals
- Medical director on site (Dr. Cook) as well as other medical staff
- Supportive Living: (2) Ranch style homes on site for up to 8 residents once they complete the 21 day program. Average stay

is 4-8 weeks. If they don't stay in the homes then staff connects them with other community organizations, housing, etc.

- MAT is offered on case by case basis
- Can provide detox, dependent on type of addiction
- Assessment is done prior to admission
- Residents having their own transportation is extremely important when moving over to transitional housing
- Looking to expand to other counties in Indiana

 - Medicaid accepted
 - 9 more sites possibly opening by June, 2018
 - Doctor monitors dosage; client decides when to step down
 - Much discussion regarding difficulty in getting records (even with signed permission). Tony said you may contact him with any issues.
 - RM will work with Tony to set up a visit/meeting with the Clinic in Lawrenceburg.
