**RE:** Legislation Affecting Reporting Requirements

# **I. Streamlined Property Tax Data Reporting**

On March 21, 2020, Governor Holcomb signed into law House Enrolled Act 1113-2020 ("HEA 1113"). In an effort to streamline the property tax data reporting requirements for local units, several sections of HEA 1113 removed the requirement for local units to submit various reports to both the Legislative Services Agency and the Department. Instead of requiring local units to submit data to both state agencies, the Department will coordinate with the Legislative Services Agency and provide the applicable data that is reported to the Department.

Beginning July 1, 2020, the following property tax data reports and submissions will only have to be reported to the Department:

Sales Disclosure Data <sup>1</sup>	(SALEDISC, SALECONTAC, SALEPARCEL)	Due January 31
Mobile Home Data	(MOBILE, APPEALMH)	Due March 1
Tax Billing Data	(TAXDATA, ADJMENTS)	Due March 16
Real Property Data	(PARCEL, LAND, IMPROVE, DWELLING, BUILDING, BLDDTL, APPEAL)	Due August 31
Oil & Gas Assessment Data	(OILGAS, OILGASALL)	Due August 31
Personal Property Data	(PERSPROP, POOLDATA, APPEALPP)	Due August 31

# **II. OPEB Reporting**

Section 70 of HEA 1113, effective July 1, 2020, transfers the oversight of other postemployment benefits ("OPEB") reporting by political subdivisions from the Department to the State Board of Accounts. Beginning with the OPEB submissions that are due by March 1, 2021, units will be reporting this information to the State Board of Accounts through Gateway.

# **III. GIS Reporting**

On March 21, 2020, Governor Holcomb signed into law Senate Enrolled Act 408-2020 ("SEA 408"). Section 39 of SEA 408 specifies that the appropriate county officer, as designated by the county executive, in each county shall, before September 1, 2021, and before September 1 of every year thereafter, submit parcel-level data to the GIS officer. Additional information related to this reporting requirement can be obtained from the Indiana Geographic Information Office.
