

First Regular Session of the 122nd General Assembly (2021)

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 2020 Regular Session of the General Assembly.

SENATE ENROLLED ACT No. 361

AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

SECTION 1. IC 16-18-2-121.6 IS ADDED TO THE INDIANA CODE AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: **Sec. 121.6. "Eyelash extensions", for purposes of IC 16-19-3-4.5, has the meaning set forth in IC 16-19-3-4.5(a).**

SECTION 2. IC 16-19-3-4.5 IS ADDED TO THE INDIANA CODE AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: **Sec. 4.5. (a) As used in this section, "eyelash extensions" means strands of silk, mink, or another synthetic or natural material that are applied one (1) at a time and fixed to an individual's natural eyelashes.**

(b) The state department shall adopt reasonable rules to ensure the sanitary operation of facilities where eyelash extensions are applied as described in subsection (a).

SECTION 3. IC 25-8-1.1-2 IS ADDED TO THE INDIANA CODE AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2021]: **Sec. 2. (a) As used in this section, "eyelash extensions" means strands of silk, mink, or another synthetic or natural material that are applied one (1) at a time and fixed to an individual's natural eyelashes.**

(b) The application of eyelash extensions as described in subsection (a) is exempt from regulation under this article.

SECTION 4. [EFFECTIVE JULY 1, 2021] (a) As used in this SECTION, "eyelash extensions" has the meaning set forth in IC 16-19-3-4.5, as added by this act.

(b) The state department of health shall adopt rules under IC 16-19-3-4.5, as added by this act, before January 1, 2022.

(c) The rules must do the following:

(1) Require an individual, before beginning to apply eyelash extensions for members of the public, to:

(A) complete a minimum number of hours of education or training specified by the state department of health in:

(i) the practice of applying eyelash extensions; and

(ii) safe health practices for the application of eyelash extensions; and

(B) receive certification or a similar recognition upon the successful completion of a program recognized by the state department of health as promoting competence and safety in the application of eyelash extensions.

(2) Require that the document attesting to an individual's successful completion of a program described in subdivision

(1)(B) be displayed prominently in the place of business where the individual applies eyelash extensions for members of the public.

(3) Establish requirements ensuring that facilities in which eyelash extensions are applied are sanitary and safe for members of the public.

(d) This SECTION expires January 1, 2023.
