Submitted to Commission: April 15, 2021

The ALJ conducted a hearing on the merits and dismissed the matter. **Subsequently an objection was submitted for consideration by the Commission. The Commission set a briefing deadline of June 21, 2021, and an oral argument of August 20, 2021.**

- ii. ICRC /Rickard/Small v. Varsity Properties Management Cop. (HOfs20060223)

Submitted to Commission: June 30, 2021

The ALJ dismissed the Indiana Fair Housing Act claim based on a Notice of Election. The ALJ dismissed the Indiana Civil Rights Law claim as non-jurisdictional. **The objection period in this matter has closed.**

- iii. Johnson v. Brook Knoll Village (EMra18040181)

Submitted to Commission: July 14, 2021

The ALJ dismissed the matter on its merits by granting a Motion for Summary Judgment filed by Respondent. **The objection period in this matter has closed.**

Submitted to Commission: July 19, 2021

The ALJ dismissed the matter after the parties reached a settlement. The ALJ recommended that the Commission accept the consent agreement filed by the Parties. **The objection period in this matter has closed.**
