PROPOSED ORDER DISMISSING CLAIMS OF DISCRIMINATION

On January 6, 2015, the Indiana Supreme Court, in a 4-1 decision, remanded this matter to the undersigned Administrative Law Judge ("ALJ") for the Indiana Civil Rights Commission ("ICRC") to grant the motion to dismiss filed by the Respondent, Fishers Adolescent Catholic Enrichment Society, Inc. ("FACES") as to both claims of discrimination because the ICRC lacks subject matter jurisdiction over FACES.

Having carefully considered all of the foregoing and being duly advised in the premises, the ALJ proposes that the ICRC enter a final order dismissing the Complainant, Elizabeth Bridgewater o/b/o Alyssa Bridgewater's complaints of discrimination.

ORDER

1. Elizabeth Bridgewater's complaints of discrimination are **DISMISSED**, with prejudice.
