FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

On July 28, 2015, Hon. Noell F. Allen Administrative Law Judge (“ALJ”) for the Indiana Civil Rights Commission (“ICRC”) entered her Proposed Findings of Fact, Conclusions of Law, And Order (“the proposed decision”).

No objections have been filed to the ICRC’s adoption of the proposed decision.

Having carefully considered the foregoing and being duly advised in the premises, the ICRC hereby adopts as its own the findings of fact, conclusions of law, and order proposed by the ALJ in the proposed decision, a copy of which is attached hereto and incorporated herein by reference.

Any party aggrieved by the ICRC’s decision may seek judicial review with the Indiana Court of Appeals within thirty days following the date of notification of such decision.

PROPOSED FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

The undersigned Administrative Law Judge (“ALJ”) for the Indiana Civil Rights Commission (“ICRC”) received notice from Trent McCain, Esq., counsel for Complainant, Caesarea Nash, that Ms. Nash wishes to pursue her claim in the State of Indiana, United States District Court.

Having carefully considered the foregoing and being duly advised in the premises, the ALJ proposes that the ICRC enter the following findings of fact, conclusions of law, and order.

FINDINGS OF FACT

1. Ms. Nash filed a complaint of discrimination on November 20, 2014 alleging the Respondent, Indiana Department of Corrections – Camp Summit Boot Camp, retaliated against her. (Complaint of Discrimination, November 2014).
2. Ms. Nash wishes to pursue her claim in the State of Indiana, United States District Court and requests a notice of dismissal from the ICRC.
3. Any Conclusion of Law that should have been deemed a Finding of Fact is hereby adopted as such.

CONCLUSIONS OF LAW

1. Under Ind. Code § 22-9-1-6(q), “upon notice that a complaint is the subject of an action in a federal court, the commission shall immediately cease investigation of the complaint


and may not conduct hearing or issue findings of fact or orders concerning that complaint.”

2. Further, Ms. Nash specifically requests the ICRC dismiss her complaint.
3. Administrative review of this proposed decision may be obtained by the filing of a writing identifying with reasonable particularity each basis of each objection within fifteen (15) days after service of this proposed decision. IC 4-21.5-3-29(d).
4. Any Finding of Fact that should have been deemed a Conclusion of Law is hereby adopted as such.

ORDER

1. Caesarea Nash’s complaint is hereby **DISMISSED**, with prejudice.
2. The Initial Pre-Hearing Conference scheduled for August 5, 2015 is cancelled.
