- i. *Gammons v. Euell Enterprise Corporation dba Pure Passion (EMse19040253)*

Date of Initial Decision: June 4, 2020

The ALJ granted a joint motion to dismiss after the Parties reached a settlement in the matter. No objections have been filed.

- ii. *Lester v. Pharmakon Long Term Care Pharmacy, Inc., D&D Pharma LTC, LLC, & D&D Pharma LTC, LLC dba Medscript (EMha16071334)*

Date of Initial Decision: April 28, 2020

The ALJ granted a motion to dismiss Respondents D&D Pharma LTC, LLC and D&D Pharma LTC, LLC d/b/a Medscript as Respondents in this matter after finding that they were not proper successors in liability to Respondent Pharamkon Long Term Care Pharmacy, Inc. No objections have been filed.

- iii. *ICRC & Banks v. Vicki New, Kirkpatrick Management CO, INC., & Twin Creeks Homeowners Association, (HOr19050297)*

Date of Initial Decision: April 2, 2020 and April 17, 2020

The ALJ dismissed the Indiana Fair Housing Act matter after a Notice of Election was filed. The ALJ dismissed the Indiana Civil Rights Law matter after Complainant filed a complaint in federal court based on the same set of facts.

April 2, 2020 and April 17, 2020 Orders were re-served on Vicki New on May 15, 2020. No returned mail has been received at the ICRC Indianapolis Office.

No objections have been filed.

- iv. ICRC & FHCCI v. Kirkpatrick Management & Twin Creeks Homeowner Association, INC. & Vicki New (HOra190402432)

Date of Initial Decision: April 2, 2020 and April 17, 2020

The ALJ dismissed the Indiana Fair Housing Act matter after a Notice of Election was filed. The ALJ dismissed the Indiana Civil Rights Law matter after Complainant filed a complaint in federal court based on the same set of facts.

April 2, 2020 and April 17, 2020 Orders were re-served on Vicki New on May 15, 2020. No returned mail has been received at the ICRC Indianapolis Office.

No objections have been filed.

- v. ICRC v. Brendan Woods Apartments (HOha18020101)

Date of Initial Decisions: December 20, 2019 and May 22, 2020

On December 30, 2019, the ALJ dismissed this matter in part with respect to the claim brought by Complainant Garcia because she interfered with discovery; however, the ALJ did not dismiss the claim brought by Complainant Wilson. On May 22, 2020, Complainant Wilson and Respondent moved for this matter's dismissal. No objections have been filed to either Order.
