FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

On March 16, 2011, Robert D. Lange, Administrative Law Judge ("ALJ") for the Indiana Civil Rights Commission ("ICRC"), entered his Proposed Findings Of Fact, Conclusions Of Law, And Order ("the proposed decision").

No objections have been filed to the ICRC's adoption of the proposed decision.

IT IS, THEREFORE, ORDERED

1. Complainant's Petition For Leave To Amend Complaint Of Discrimination is **GRANTED**.

- 2. The ICRC hereby adopts as its own the findings of fact, conclusions of law, and order proposed by the ALJ in the proposed decision, a copy of which is attached hereto and incorporated herein by reference
- 3. All provisions in the Order in the proposed decision shall also apply to Tomasso & Carmela, Inc. d/b/a Enzo Pizza.
