<b>INSPECTION OBSERVATIONS AND COMMENTS</b>
<p>Upon entering 1600 West Mishawaka Road, Elkhart, Indiana 46517, it was apparent that there was a name change to the source. The name Fusion Wood Products was on the sign. A re-check of the address was completed and confirmed that the address was correct for Great American Desk Corporation.</p> <p>Mr. Ryan Nichols, Fusion Wood Products (FWP), stated that an air application was submitted to IDEM OAQ in October 2018 for FWP. FWP received a Registration on March 14, 2019. Mr. Nichols stated that Great American Desk Corporation was located at one time at this address. Great American Desk Corporation's last Registration was issued on February 19, 2019, Second Administrative Amendment.</p> <p>IDEM OAQ has not received a revocation for Registration 36755. The last Annual Notification submitted was for the 2015 year. In searching Indiana BIZ, a Certificate of Dissolution for the Great American Desk Company, Inc. was found, and the dissolution was effective on October 20, 2016. Registration 36755 will be revoked through IDEM OAQ, as the previous business owner, Mr. Kevin Clinton could not be reached. A phone call was placed to Ms. Eva Clinton, listed on the Articles of Incorporation, on 08/31/2022 she was only able to verify that the business was no longer in operation.</p>
