

Application for Petroleum Orphan Sites Initiative (POSI)

Please complete this form when applying for POSI funding from the Indiana Brownfields Program (Program) for sites potentially contaminated with petroleum products from leaking underground storage tanks (USTs) that cannot be addressed by a responsible party. Criteria for funding eligibility are listed below:

- Sites with no viable responsible party due to dissolution, being defunct or bankrupt, or having demonstrated an inability-to-pay verified by IDEM
- Sites that are effectively abandoned due to tax delinquency or for which there is no known responsible party
- Sites with a responsible party solely based on current ownership (e.g., inheritance), but the owner did not cause or contribute to the historic contamination or own and/or operate at the site at the time of the disposal or release

If you are unable to provide the information necessary for funding qualification, please state why the information is unavailable and provide any available information that may be relevant to potential liability or site ownership history.
