## EXECUTIVE SUMMARY

---

As required by IC 5-1.2-4-37.5, the Public Finance Director of the State of Indiana on behalf of the Indiana Finance Authority (“IFA”) submits this annual report to the Indiana General Assembly concerning the IFA’s Lead Sampling Program for Schools and Child Care Facilities (“Lead Sampling Program”).

Since 2019, the IFA’s Lead Sampling Program has assisted over 300 public school and child care facilities in the testing of their drinking water for the presence of lead. The results of this sampling show that 3%, or approximately 400 out of 13,000 samples, contained a presence of lead above the U.S. Environmental Protection Agency (“EPA”) Action Level of 15.0 parts per billion (“ppb”), and that 36% of schools and 15% of child care facilities had at least one fixture that exceeded the Action Level. All test results were shared with facility representatives so that appropriate remediation activities could be taken. The most common remediation actions taken by schools and child care facilities include replacing faucets (74%), followed by the installation of signage to indicate affected fixtures are for “hand-washing only” (11%).

The IFA will continue to offer the Lead Sampling Program in 2024 or until available funds are expended.

## INTRODUCTION

---

Since 2019, the IFA has implemented its Lead Sampling Program for Schools and Child Care Facilities<sup>1</sup> (“Lead Sampling Program”) to help schools and child care facilities assess if there is a presence of lead in drinking water within their buildings. It is a voluntary program and the successor to the IFA’s 2017-2018 voluntary Lead Sampling *in Schools* Program, developed in coordination with the Indiana Department of Environmental Management (“IDEM”), that led to the sampling of 915 public school buildings and the collection of 57,000 water samples<sup>2</sup>.

In 2023, legislation was adopted, IC 5-1.2-4-37.5<sup>3</sup> (the “Act”), that requires the IFA to report on its Lead Sampling Program activities. In summary, the Act requires:

- An annual report on the IFA’s Lead Sampling Program’s work in schools, preschools, and child care facilities.
- Identification of the number of schools, preschools, and child care facilities that were tested by the IFA’s Lead Sampling Program.
- Identification of the actions taken through the IFA’s Lead Sampling Program to eliminate the danger of lead contamination in the drinking water of schools, preschools, and child care facilities.
- Identification of the funds available to the IFA to conduct further drinking water testing and remediation.

Facilities eligible for the Lead Sampling Program include all Indiana public K-12 schools recognized by the Indiana Department of Education (“DOE”) and all child care facilities recognized by the Indiana Family and Social Services Administration (“FSSA”). In Indiana, there is not a separate category for preschools; they are either part of a K-12 school or a child care facility. Therefore, the Lead Sampling Program uses these same categories to report its preschool data.

## PROGRAM IMPLEMENTATION

---

Implementation of the IFA's Lead Sampling Program is based on the EPA's "3Ts" for Reducing Lead in Drinking Water in Schools and Child Care Facilities<sup>4</sup> guidance document, which focuses on "Training, Testing, and Taking Action". The IFA Lead Sampling Program incorporates the pillars of the 3Ts as such:

Training – Indiana school and child care facility managers are trained on possible sources of lead in drinking water and how to collect samples.

Testing – Collecting samples at Indiana school and child care facilities.

Taking Action – Participants are required to remediate problematic fixtures, re-sample to confirm effectiveness, and share results with their constituents.

Since its inception, the Lead Sampling Program has defined an exceedance as a test result that meets or exceeds the U.S. Environmental Protection Agency ("EPA") Lead and Copper Rule Action Level of 15 parts per billion (ppb). An Action Level is not a measure of health effects. Rather, it serves as a signal to take steps to reduce the lead concentration. On November 30, 2023, the EPA released the proposed Lead and Copper Rule Improvements, which lowers the Action Level to 10 ppb. The IFA Lead Sampling Program will revise its exceedance level to mirror the EPA's once the final rule is adopted.

The Lead Sampling Program is funded by two U.S. Environmental Protection Agency ("EPA") grants: the Voluntary School and Child Care Lead Testing and Reduction grant<sup>5</sup> and the Reducing Lead in Drinking Water grant<sup>6</sup>.

As of the date of this report, the following funds are available for the Lead Sampling Program for sampling assistance and remediation assistance:

The Lead Sampling Program’s sampling assistance covers the cost of an online database to manage sample results, sampling bottles, postage to send the bottles to the facilities and to the laboratory once collected, and the sample analysis cost. Schools and child care facilities are responsible for collecting samples and costs associated with remediation actions identified through sampling. The IFA provides training webinars to guide participants through the process, as well as remediation recommendations specific to each facility’s results. If funding becomes limited, the IFA may prioritize funding based on the age range and financial need of the population served and the age and use of the facility.

While sampling assistance is available to all eligible participants, remediation assistance is only available to facilities that serve a Disadvantaged Community, as required by the EPA terms of the grant. A Disadvantaged Community is defined by the IFA’s Drinking Water Intended Use Plan<sup>7</sup> as a population with a median household income below 80% of the State median household income or a facility that serves 50% or greater number of children that qualify to receive free and reduced meals. Remediation assistance includes costs related to the removal, replacement, and otherwise remediation of drinking water fixtures, pipe, plumbing components, and lead service lines.

The IFA accepts applications to the Lead Sampling Program on an ongoing basis but conducts two official recruitment campaigns a year, in August to both schools and child cares and in January to child care facilities only, because schools usually need the entire school year to complete their work. The IFA’s outreach efforts include emails and paper mailings to eligible participants, and notifications to partner organizations. The IFA’s Lead Sampling Program website contains fact sheets and informational videos<sup>8</sup> to promote the program.

The Lead Sampling Program’s partner organizations play an important role. Below is a list and short description of assistance provided.

- Indiana Department of Environmental Management – technical and regulatory guidance
- Indiana Department of Health – technical guidance and outreach with county environmental health specialists and public health nurses
- Certain county environmental health specialists and public health nurses – assistance collecting samples
- Indiana Department of Education – contact information, technical guidance on facility management
- Indiana Department of Family and Social Services Association - contact information
- Indiana Association of Public School Superintendents – outreach assistance
- Indiana Association of School Business Officials – outreach assistance
- Indianapolis Chapter of the National Association for the Advancement of Colored Persons (“NAACP”) - In 2022, the IFA entered into an agreement with the Indianapolis Chapter of the NAACP to provide outreach and sampling assistance to child care facilities located in Marion County. The NAACP conducts outreach via emails and phone calls to encourage facilities to apply for program assistance and provides technical support to child cares, including on-site assistance to map facilities and collect water samples. The NAACP also connects facilities to other sources of grant funding and lead-free resources.

Sharing results is a requirement of the IFA Lead Sampling Program. Participants are required to share results with their constituents. The IFA shares a summary of the Lead Sampling Program’s enrollment, sampling, and remediation results on its website<sup>9</sup>. December 2023 enrollment report is attached as Appendix A.

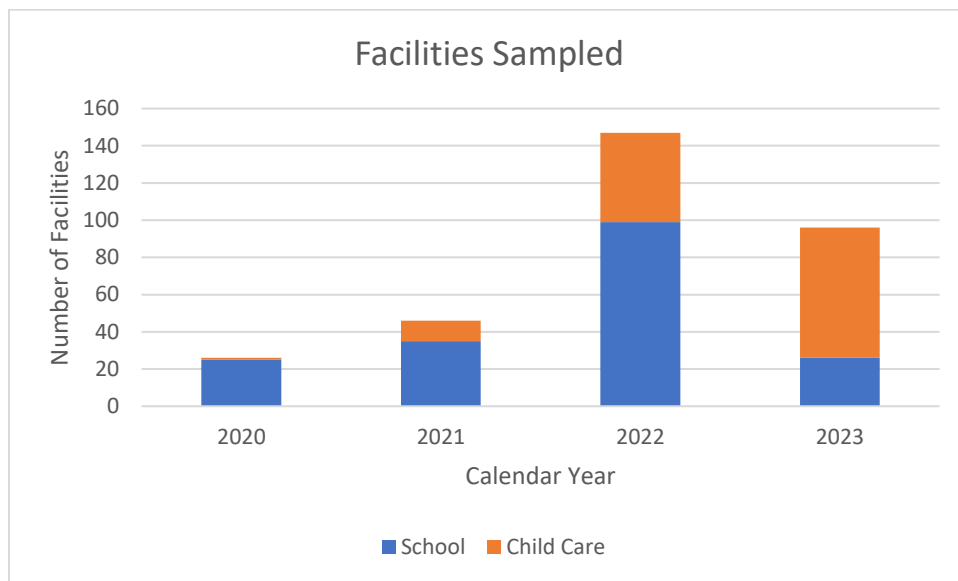

## DISCUSSION OF RESULTS

---

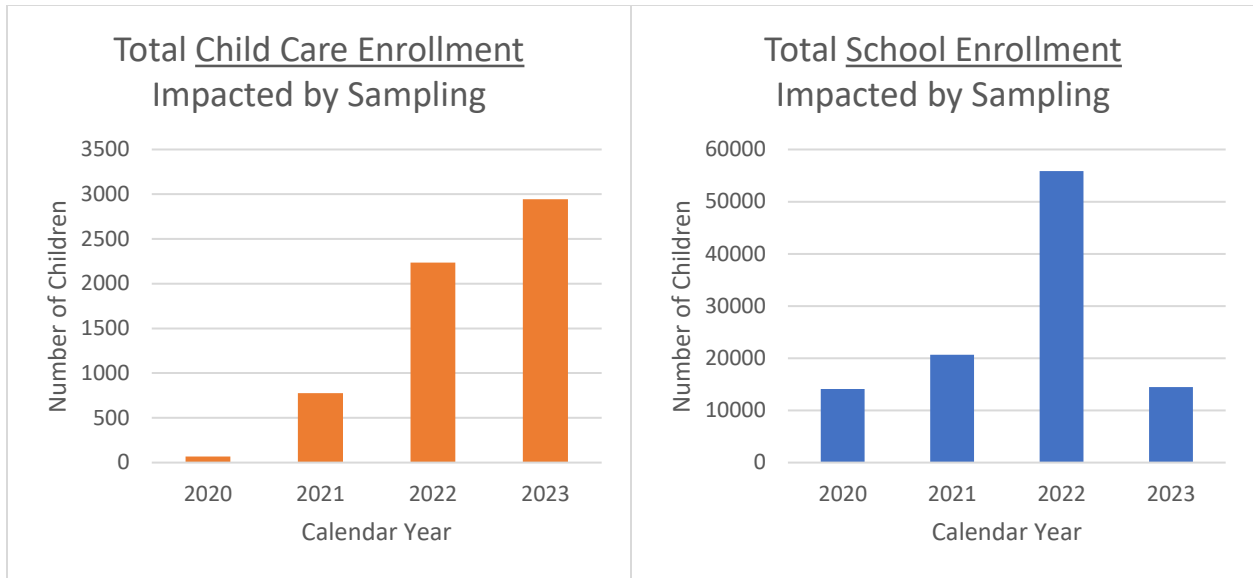
### *Results: Facility Information*

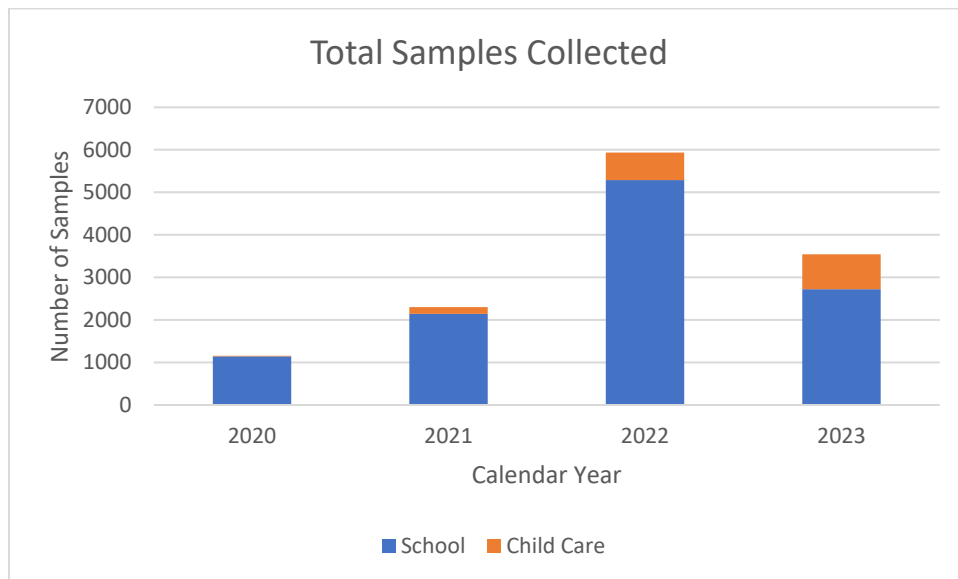




**Figure 2: Number of Children Impacted by Facility Type and Year.**

Since the program began in late December of 2019, a total of 315 facilities, 185 public schools and 130 child care facilities, have completed the Lead Sampling Program, impacting over 111,000 children (105,000 in schools and 6,000 in child care facilities). See Figures 1 and 2. No data is reported for 2019 since first samples were collected in 2020.



**Figure 1: Number of School and Child Care Facilities Sampled by Year.**

*Results: Sample Collection*

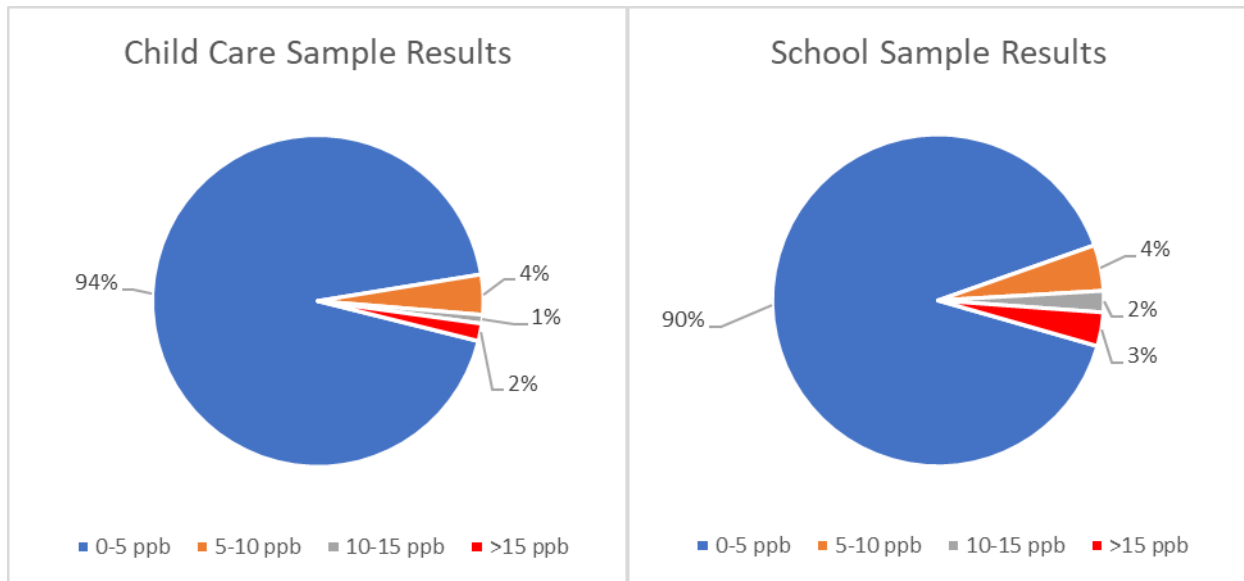
Since 2019, the Lead Sampling Program has collected nearly 13,000 samples from school (11,300) and child care (1,600) facilities for an average of 61 samples per school building and 13 samples per child care facility.



**Figure 3: Number of Samples Collected by Year.**

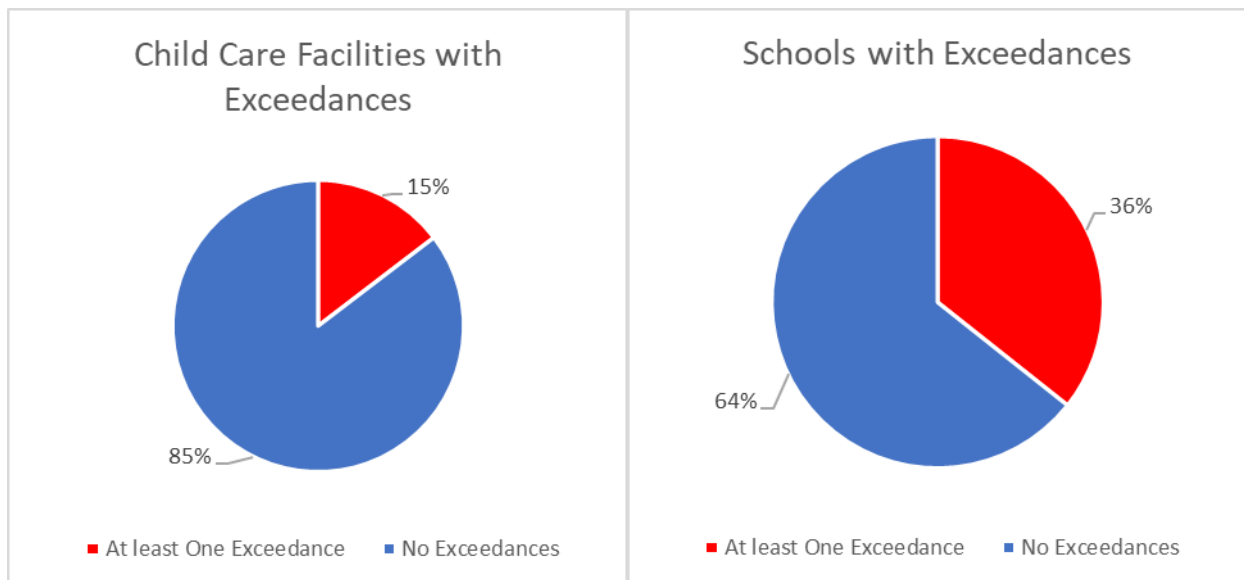
The results of this sampling show that 3%, or approximately 400 out of 13,000 samples, contained a presence of lead above the U.S. Environmental Protection Agency (“EPA”) Action Level of 15.0 parts per

billion (“ppb”). More specifically, 2% of child cares and 3% of schools have samples above the 15.0 ppb Action Level. See Figure 4.



**Figure 4: Sample Results for Child Care and School Facilities.**

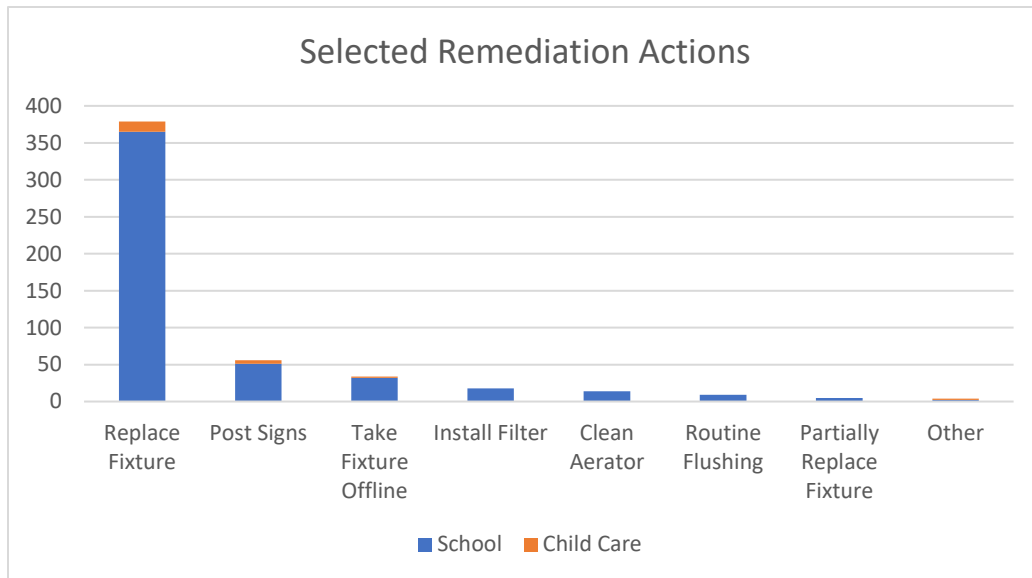
Additionally, 27% of facilities had at least one fixture that exceeded the Action Level, or more specifically 36% of schools and 15% of child care facilities. See Figure 5.

### Results: Remediation Actions

The most common action taken to address problematic fixtures is replacement (74%), followed by posting a “hand washing only” sign (11%). See Figure 6.

## CONCLUSIONS

---

The first two years of the Lead Sampling Program were hampered by the closing or reduced operations of schools and child care facilities due to the COVID-19 pandemic. However, since then, and with the support of numerous partner organizations, the voluntary program has made steady strides in assisting schools and especially more child care facilities in 2023.

The sampling results show that only a small percentage (3%) of samples test above the 15 ppb Action Level, and less than a third of facilities (27%) had at least one exceedance. Replacement of problematic fixtures is the most common way facilities address remediation which is always followed by a post-remediation sample to confirm effectiveness and sharing data with constituents.

The IFA will continue to help schools and child care facilities assess if there is a presence of lead in the drinking water within their buildings by offering the Lead Sampling Program in 2024 or until funds are expended.
