We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated February 3, 2017. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for the:

- Evansville Metropolitan Planning Organization (EMPO)
