We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated August 4, 2015. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for the Evansville Metropolitan Planning Organization (EMPO), the Indianapolis Metropolitan Planning Organization (IMPO), and the Michiana Area Council of Governments (MACOG).

The amended TIP has been endorsed by the appropriate Metropolitan Planning Organizations (MPOs). The projects listed in the attached STIP tables (Attachment 1) are eligible for FTA funding.

We have determined that the amendment to the TIP and STIP are financially constrained and consistent with the relevant MPO and statewide transportation plans. The projects were developed in accordance with the requirements of 23 CFR 450, and are exempt from the air quality conformity determination process. The project additions are approved for the FY2016-2019 STIP.
