We have reviewed the State Transportation Improvement Program (STIP) amendment requests you submitted via correspondence dated May 18 and 24, 2012. The requests amend the Transportation Improvement Programs (TIPs) to add projects for the following:

- West Central Indiana Economic Development District
- Indianapolis Metropolitan Planning Organization
- Northwestern Indiana Regional Planning Commission

The amended TIPs have been endorsed by the appropriate Metropolitan Planning Organizations (MPOs). All of the projects listed in the attached STIP amendment table (Attachment 1) are eligible for FTA funding.

We have determined that the amendments to the TIPs and STIP are financially constrained and that the projects are consistent with the MPO and statewide transportation plans. A resolution approving an AMENDMENT to the SFY 2012-2015 TRANSPORTATION IMPROVEMENT PROGRAM, herein after referred to as the TIP, as requested by the Terre Haute Transit Utility (THTU).

WHEREAS, West Central Indiana Economic Development District, Inc. (WCIEDD) is the Metropolitan Planning Organization (MPO), designated by the Governor of Indiana, for the Terre Haute Urbanized Area and the Vigo County Metropolitan Planning Area (MPA) pursuant to 23 CFR 450.310 (Designations); and

WHEREAS, The Terre Haute Transit Utility requested this amendment to add the projects described in the attached STIP Amendment and/or Modification Report, dated April 18, 2012; and

WHEREAS, A draft version of a the attached STIP Amendment and/or Modification Report was posted on the WCIEDD website for a 10-day public comment period, from April 18, 2012 to April 26, 2012, and no public comments were received; and

WHEREAS, The MPO determined the projects described in the aforementioned and attached report are exempt per 40 CFR 93.126 and that there was no need to update the conformity analysis or to issue a new conformity finding in connection with these exempt projects; Now

THEREFORE BE IT RESOLVED, The WCIEDD Transportation Policy Committee hereby approves the aforementioned amendment to the TIP, described in the attached *STIP Amendment and/or Modification Report*, dated April 18, 2012.
